### **1. Introduction**

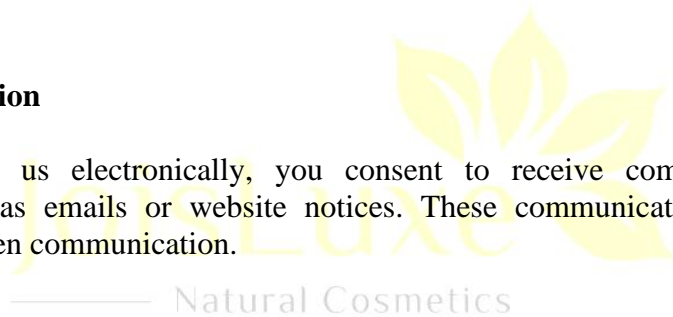

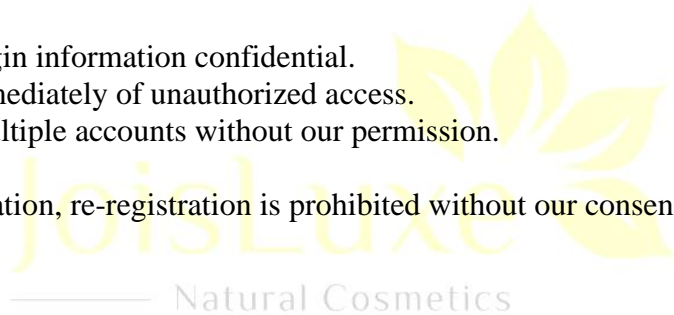
